Leadership Gainesville (LG) is a 10-month community leadership program designed to develop the skills leaders need to excel. The program includes a combination of in-depth issue seminars and skills development designed to enhance self-awareness of leadership approaches.

The program provides community immersion experiences and advanced skill development which enable participants to explore critical issues in Gainesville's business environment.

ESTEEMED HISTORY OF LEADERSHIP GAINESVILLE

In the early 1970's, the Gainesville Area Chamber of Commerce became aware of the need to create a forum for leaders from both the community and the University of Florida to discuss issues of importance to Gainesville and the State of Florida.

In 1972, Carol Gray, the Executive Vice President for the Chamber, discussed the need for a Leadership Gainesville program with then President, Finley Cannon, Jr., and several past presidents. At the time, there were very few leadership programs in the South and none were available in the State of Florida. Leadership Gainesville would be the first program in the state.

In 1974, Canon and Gray hired a consultant, Gerald Horton, who was instrumental in creating the Leadership Atlanta Program, to coordinate the Leadership Gainesville Program. Brochures and applications were sent to all Chamber members and selected individuals at the University of Florida. The first person to enroll was Mel Fried: the second was Finley Cannon. Within a week, the inaugural Leadership Gainesville class was full.

Today, Leadership Gainesville is the single most unique opportunity for emerging and existing leaders to build, collaborate, and steward a vibrant, interconnected community in Gainesville and the surrounding area. The program identifies, educates and develops leadership skills in approximately 50 individuals each year following a competitive application process.

The goals are simple... to **EXPAND** leadership potential ... to **IMPROVE** communications between present and future leaders... to **INSPIRE** new leaders to tackle tough community challenges in an informed and responsible manner.

If you want a deeper connection to the community and believe leadership is an investment worth making in your career and civic stewardship, Leadership Gainesville is for you!

- Tuition is \$1,995 and **due in-full by July 26, 2019**.

SELECTION CRITERIA

- Application to LG is open to persons living within the Greater Gainesville region.
- Applicants must represent a Chamber-member business.
- Class size will not exceed 60 members.
- Class members are chosen by a selection committee on their own merit based upon the information completed on the application.
- Nominees must have the full support of the organization they represent.
- Attendance at monthly sessions is mandatory.
- In reviewing applications, the selection committee looks for potential participants who demonstrate the following:
 - Commitment and motivation to serve Gainesville and the region in a volunteer capacity.
 - Policy shaping responsibility or position of leadership in employment and/or volunteer organizations resulting in the potential to have significant influence on important issues facing the community.
 - Ability to make the time commitment required by the program.
 - Previous volunteer experience.

TUITION & SCHOLARSHIPS

If accepted into the Leadership Gainesville program, you and/or your employer/sponsor will be billed for the tuition fee, which covers all program costs including meals. Tuition is \$1,995. **An application fee of \$25 is required and is non-refundable.** Applications must be received on or before **June 14, 2019**. Applications received after this date will not be eligible for LG Class 46. If selected, full tuition is due by **July 26, 2019** and is non-refundable.

Limited scholarship opportunities are available through the Leadership Gainesville Alumni Association for accepted applicants whose tuition is not sponsored. Please contact the Greater Gainesville Chamber of Commerce at 352-334-7100 if you are in need of scholarship funds.

COMMITMENT

To graduate from Leadership Gainesville, participants are expected to attend all sessions. Participants should notify the Chamber immediately if unable to attend. Participants with multiple absences may be asked to withdraw from the program with no refund.

The LG 46 program starts in August 2019 and ends May 2020. LG meets one full day per month, sessions are generally held on the second Thursday of each month from 8 a.m. to 5 p.m. for the duration of the 10-month program.

Upon acceptance, attendees will receive a schedule of dates for each session of the 10-month program. If an applicant is unable to commit to the dates for the session, the applicant's admission will be revoked.

I understand the requirements of the Leadership Gainesville program and if selected will devote the time and resources necessary to complete the program and become an active member of the Leadership Gainesville Alumni Association and one other community organization upon graduation. I also understand that I will be required to complete alternative assignments for any missed program days or portion of days. Additionally, I acknowledge that if I miss two sessions, I may be asked to withdraw from the program and no portion of the tuition will be refunded.

I understand the above commitments and agree to be bound by them in signing this application.

I understand that the Greater Gainesville Chamber of Commerce, through its Leadership Gainesville program, selects participants in such program based on a variety of considerations.
